1. Introduction:

- The purpose of the Scope of Work is to outline the requirements for a comprehensive Facility Condition Assessment (FCA) at 2000 Marbury Drive.
- The assessment aims to provide a detailed analysis of the existing building's condition, identify deficiencies related to codes and maintenance, prioritize maintenance needs, estimate costs, and make phasing recommendations.

2. Project Overview:
